IDENTIFICATION LABELS

In our continuing campaign to ensure the public are aware of the official Street collections, we will provide the number of identification labels required. **It is now a condition of the permit that the date identification label must be displayed by all collectors.** To ensure ease of display on your collectors' clothing, we can provide clear plastic holders (with a pin) to enclose the permit, these are available at a cost of 10p each and are reusable. When submitting this application, please enclose your payment for the precise number of plastic holders required (10p each). Cheques and Postal Orders should be made payable to Peterborough City Council.
