In all other respects the above Order and its previous amendments remain in force.

This Amendment Order will come into operation on the 15th day of November 2021 and may be cited as The Council of the City of Peterborough (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Amendment No. 77 Order 2021.
