## New standards regime

The [Localism Act 2011](http://www.legislation.gov.uk/ukpga/2011/20/contents/enacted) (<http://www.legislation.gov.uk/ukpga/2011/20/contents/enacted>) introduced significant changes to the standards regime. 'Standards for England' ceased its regulatory function on 31 January 2012 and was abolished on 31 March 2012. The remaining elements of the regime were abolished on 1 July 2012.
